



- Knowledge of the state's museums landscape
- Support for the state's museum landscape
- Advice in all museum-specific problems:
 - Full-time and volunteer museum personnel
 - Museum sponsors/supporters and initiatives
 - Regional and communal politicians
 - Regional and communal administrations
 - Other societal groups

- **no allocation of public means without advising**

What We Provide

- Independent of organizational level
- Individual advising
- Project-associated advising
- Project implementation
- Offerings for quality management

How We Advise

- Individual advising + Collective advising
- Networking + Capacity building
- Collaboration with government ministries or public entities in developing, continuing, and actively cooperating in museum development plans
- Preparing assessments, position papers, and recommendations
- In individual cases: disbursement of funds

Fields of Work in Museum Advising 1

Collecting and Preservation

- Support in the creation and continuing development of collection ideas
- Information on new acquisitions, deacquisitions, exchanges, and releases
- Advice and support for conservation and restoration measures
- Assistance with conservation and security planning in the building and renovation of museums
- Preparation of manuals for conservation, emergency planning, and the preservation of cultural artifacts

Fields of Work in Museum Advising 2

Documentation and Research

- Assistance with documentation: inventory, scholarly cataloging of collections (analog and digital) and provenance research
- Development of assistance with documentation (writing instructions, thesauruses, classification, standardized vocabulary, etc.)
- Support and fostering of scholarly cataloging

Fields of Work in Museum Advising 3

Exhibition and Presentation

- Advice and support for museum and exhibition concepts
- Support in questions of presentation and visitor orientation
- Assistance and support in the preparation of museum educational concepts
- Advising on and coordinating exhibition projects
- Recommendations for barrier-free building and exhibiting
- Advice on publishing permanent collections and exhibitions
- Presentation of special and travelling exhibitions
- Advice on the publication of museum and collection guides, online data banks, internet portals, etc.

Fields of Work in Museum Advising 4

Museum Operations and Museum Management

- Information on a variety of support and sponsoring models
- Advice and support for processes of organizational modernization and restructuring
- Planning for personnel requirements
- Qualification of personnel
- Mediating in the recruitment of suitable skilled personnel
- Expert assistance with funding methods
- Advice on the raising of third-party funds
- Assistance with strategic planning, marketing, and public relations


Given subsidies


